THE BUSINESS END

CONFIRMATION OF BOOKING, NUMBER OF GUESTS & PAYMENT OF HIRE FEE

The hire fee must be paid in order to secure your booking. Should you cancel your booking at any time prior to the event, this amount is non-refundable.

Confirmation of guest numbers must be advised a minimum of 28 days prior to your booking. This will be considered a minimum number not subject to reduction. If the number of guests drops below your original number, you will be charged according to the minimum number originally given. Should the number of guests exceed the minimum, the venue will endeavour to accommodate them, but no guarantee is given. Should such extra guests be accommodated, the appropriate charges will be made accordingly. We will advise you of any additional charges and these should be paid within two days.

PAYMENT

Payment of your account (determined by the number of persons attending your function, combined with your choice of menus and other options) may be made by cash, direct deposit, Visa or Mastercard 28 days prior to your function. If payment is required to be made by cheque, this payment must be cleared 28 days prior to your function date. Credit card surcharge applies.

CANCELLATION

Hire fee is non-refundable once paid. Notice of cancellation must be made in writing and the following conditions apply: if notice is given within twenty one (21) days prior to the event, 50% of the catering fee will be refunded. Any cancellation made in less than twenty one (21) days will be fully charged.

TENTATIVE BOOKINGS

A tentative booking will be held for a period of seven (7) days and Management reserves the right to terminate a tentative booking after this time. Please ensure you leave your daytime or mobile telephone contact numbers with our friendly staff when making a tentative booking.

PRICING & MENUS

Whilst we endeavour to maintain our prices quoted at the time of booking, they may be subject to price increase which we will inform you in advance of your function date. Beverage prices are subject to change and are based on CPI increases (Consumer Price Index). All prices quoted are inclusive of GST. When alterations are requested to menu options and room settings, prices may vary depending on the changes you require. Special diet menus are available on request, please advise us of any allergies.

CAKES & FOOD

Due to Health & Safety regulations, no food may be brought into the function other than the food provided by the venue. However, cakes such as Birthday / Wedding cakes etc. may be brought into the venue provided it has been purchased from an accredited food and beverage establishment.

DAMAGE & INJURY

You assume all responsibility for all and any property damage and person injury caused by you or your guests and anyone else under your control (including without limitation, a DJ or Entertainer) and agree to compensate us for any related costs, expenses, liabilities and losses. If a DJ or Entertainer is used, you are advised to ensure that they have suitable insurance cover. The Duty Manager or Security shall be entitled to remove anyone from the premises whose behaviour is felt to be inappropriate.

LEGISLATION

Under current legislation, patrons can only consume alcohol if they are over the age of eighteen (18). Proof-of-age may be requested by the venue staff at any time. As we operate a licensed premise, under no circumstances can alcohol be brought onto the premises and all Responsible Service of Alcohol Laws apply. Any breaches of the liquor licensing laws may result in the termination of your function without refund, or guests being refused service and asked to leave the premises immediately. Please note a current Australian Driver's License or Passport, International Passports and Proof-of-age 18+ cards are acceptable forms of identification.

MINORS

Minors are allowed inside the venue only if accompanied by their parent or legal guardian however will not be permitted to stay beyond what is legally permitted.

BEHAVIOUR & ENTERTAINMENT

If the Property has reason to believe that a booking or function will affect the smooth running of the Property's business, either regarding security or reputation, Management reserves the right to cancel the booking / function and / or remove any disruptive individual without liability.

The Property has no responsibility to the organiser for any costs, damages or expenses that may be incurred in relation to the termination of the function.

All live entertainment and music must be pre-approved by Management before booking. Failure to do so may result in the cancellation of the event.

The Property may exclude or remove any persons or inappropriate possessions from your function or from the premises at Management discretion.
